He hereby voluntarily assumes all risk of injury or death to himself which may result from his participation in such events, and for himself, his heirs, legatees, personal representatives and assigns, does hereby release Dodge City Roundup, Inc., Harry Vold Rodeo Company or any other stock contractor, the Dodge City Days Committee, and their officers, directors and members, or their agents or employees from all claims, demands, actions and causes of action of any sort for injury to his person, or his death, resulting from such participation, or from his participation as a barrel man.

VOLUNTEER understands that neither ROUNDUP, Harry Vold Rodeo Company or any other stock contractor, nor any of the other persons or organizations connected with the Dodge City Days/Dodge City Roundup Rodeo will provide any insurance to pay medical, hospital, or other expenses which may be incurred as a result of injury to VOLUNTEER, nor will they furnish any funeral or burial insurance in the event of his death.
